# **Allianz Income and Growth**

Allianz Global Investors Fund AMg / AMgi / AMg2

Fund Selector Asia Awards Hong Kong 2020, Mixed Asset – Gold





FE Fundinfo used its Crown Rating methodology to assess funds based on alpha, volatility and consistency of performance from from 30 June 2016 to 30 June 2019 and create a shortlist for 14 asset classes. The shortlist was given to an independent panel of professionals from Asia's fund selector community in Hong Kong. Each judge selected the funds he or she thought would outperform in the next 12 months.
